- 1) Log in to your [Wild Apricot](#) account
 - You must be a current NCSSFL member to login and register for the annual meeting.
 - Your login name is the email address you listed as your preferred email.

 - You will not see the meeting registration information until after you log in.
- 2) Renew your membership if needed
 - a) Make sure your membership is current.
 - b) Dues for the 2026-2027 fiscal year are due by October 1, 2026
 - c) Annual dues are \$50.00
- 3) Register for the Annual Meeting
 - a) Once you log in, you will see a link to the annual meeting registration on your opening page.
